## IV.

### The ACLU's Involvement in, and its Wins and Losses at the U.S. Supreme Court (Alphabetically)<sup>8</sup>

In the following chart, the 1,118 ACLU / U.S. Supreme Court cases are listed alphabetically and the chart indicates where each case (with a short analysis) can be found in the four-volume set. For example, Case No. 3. *Adams v. Williams* is case No. 227 in Volume 1 of the four-volume set.

During the years of putting this data together, I was asked on numerous occasions how many times was the ACLU a party in their Supreme Court cases. The chart contains not only the answer to that question, but shows which cases the ACLU was a party. As you can see in Column B., of the 1,118 cases, the ACLU was a party just six times.

The chart also shows that the ACLU filed amicus briefs in 970 cases, 86.76% of the cases. The chart also shows which cases were wins and losses. Column C., Attorney of Record/ACLU Attorney, is not complete and it would take years to complete if it ever could be done accurately.

Completing that column would probably entail tracking each lawyer listed on each Supreme Court Opinion, and researching which of those attorneys met this project's criteria to be counted as an ACLU attorney. Therefore, column C. is not totaled, as the incomplete result would be meaningless.
